Notes:

- 1) A \$100 penalty shall be assessed, in addition, to the sign permit fee, for failure to obtain a required sign permit prior to any installation of the sign(s).
- 2) All planning clearance, fence permit and banner permit fees shall be doubled if an owner, lessee or contractor fails to obtain a permit or planning clearance prior to the construction, alteration or erection of any structure, mobile home, wind-driven sign or banner.
